New Appointed Representative Regime

With 1 month to go, time is running out for Principal firms to comply with the new **Appointed Representative regime** which comes into effect from 8th December 2022.

Principal firms are facing increasing pressure as they must also comply with the new Consumer Duty and Financial Promotion rules for their Appointed Representatives (ARs).

What should Principal firms be doing under the AR regime?

Principals must have stronger and better oversight of their Appointed Representatives. Principals should oversee individuals at ARs to a comparable standard as if they were directly employed by the Principal.

- Principals must collect more data on ARs, which mean they need adequate staff and robust processes. This includes an annual, documented review of each AR, including annual assessment of the fitness and propriety of AR staff, AR's activities, and the appropriateness of the AR's business model.
- Firms should implement a risk framework for their ARs and keep this under ongoing review.
- Principals should carry out increased monitoring, including AR visits which would align with the risk assessment for the AR.
- Principals must sign off annually that they are compliant with their obligations and ensure there is adequate management information on their AR business and monitoring activities.
- Principals must adhere to the additional FCA reporting and notification requirements.
- Enhance policies and procedures covering ARs and reviewing AR contracts.

Implementation Deadline

The rules come into effect from 8th December 2022. Limited transitional provisions apply.
